Pursuant your application and subsequent interview, we have the pleasure in employing you in the above post under the following terms and conditions:-

1. Your appointment is for three year period from 12.12.2022. The period of contract is from 12.12.2022 to 11.12.2025 . As this is a contract appointment when the contract period is over you will be automatically removed from the role of the establishment. The contract of employment may be renewed for any further period on terms and conditions mutually agreed by both. The first 6 months you will be treated as an Observer to the work entrusted and if found fit for the work and organization we will continue the period. Otherwise you will be terminated
2. Be it clearly understood and agreed that your appointment is for a specific period as stated above and no notice or pay in lieu thereof or retrenchment compensation will be payable to you by the Management at the end of tenure with the establishment.
3. You will be bound by the Service Rules, regulations and office orders in force and framed by the establishment from time to time in relation to your service conditions which will form part of terms of employment.
4. Your working hours will be 8.30 A.M. to 5.30 P.M. on 6 days per week. However you have to be present in the campus by 8.00 a.m. to 6.00 p.m (including 2 hours interval) for an effective involvement in the academic affairs.
5. You are responsible for discharging duties assigned by the HOD / Principal / CEO & Secretary / Chairman& Managing Trustee of the Trust and Institutions.
6. Your salary will be proportional to the number of days attended by you in the College. Only Sundays and eligible Public Holidays will be considered as authorized holiday and you will be eligible for salary for these days. However, if you are absent on preceding or proceeding days of such holidays, intervening holidays would be considered as absence without salary. It is your duty to mark your attendance in the attendance register&biometric system before the commencement of the working hours of each day and on conclusion of the working hours.
7. You shall not leave the Institution before completion of one academic year service. If required, you can leave the Institution by giving proper resignation with prior intimation of three months notice before the end of academic year after completion of all academic and university related works and you will not be eligible for any compensation or remaining wages for unexpired period of employment. Your services can be terminated without notice during the period if your services are found to be unsatisfactory by the Management. In case of emergent situations, a faculty member may leave the services of the College by giving 3 months salary in lieu of notice period, provided he/she completes all the academic duties and satisfactorily hand over the same to the Principal. However, no notice shall be required to be given in case your services are terminated for any misconduct / indiscipline.
