Examination held on 16.09.2017 and document verification held between 22.10.2018 to 25.10.2018 for the post of Nursing Officer, Competent Authority, is pleased to offer Mr./Ms.MOHAMMED AJMAL MT Temporary appointment to the post of Nursing Officer in the Level -7 in Pay Matrix (pre-revised pay band-2 ₹ 9300-34800 with grade pay ₹ 4600/-) with entry pay of ₹ 44900/- plus usual allowance as admissible from time to time to Central Govt. Employees of similar category stationed at Delhi/New Delhi and rural centre presently located at Ballabgarh (Haryana)/National Drugs Dependency Treatment Centre (Ghaziabad)/NCI, AIIMS campus at Badsha, Jhajjar.
